## **CODE OF ETHICS IN RESEARCH**

- 3. rectify significant errors in the published data, through the issuance of erratum or withdrawal of the data.
- 4. avoid statements or declarations that could misguide.

- 5. strictly follow the plagiarism policy of Vidyapith (as per UGC norms).
- 6. provide citation for the information/data used from the other sources.
- 7. provide proper acknowledgment of resource/funding sources of the research.
- 8. claim authorship to only those who made a significant contribution towards the research accomplishment.
- 9. be transparent in the use and disbursement of resources for research.
- 10. declare conflict of interest if any in publication of research findings.
- 11. ensure that research results are accessible to the public after completion of the research.
- 12. publish research findings only in authentic/genuine journals/books/compendium.
- 13. follow the guidelines prescribed in the research bye-laws
- 14. keep the premises clean and healthy.
- 15. not to create any inconvenience to any other researchers.
- 16. not to encourages others to breach any rules of the Vidyapith. Breaching of rules and regulations of Vidyapith would cause termination from the university and the decision of the Vice-chancellor will be final in this regard.
- 17. to wear Khadi in Vidyapith's campus.
- 18. to conduct themselves in such a way as to bring recognition/honour to themselves and to the University while attending functions/conferences/workshops.
